2009 Greensboro Partnership Legislative Agenda

Budget Update

We have a budget. Earlier this week, the North Carolina General Assembly passed a \$19 billion budget for the 2009-2011 biennium. The budget comes over a month after the start of the fiscal year and generates approximately \$990 million in new revenue. Due to the state's poor fiscal condition and to avoid some of the most extreme cuts to state services, it includes the following tax increases:

1-cent increase to the state sales tax through January 1, 2011.

(In Guilford County, the sales tax rate will be 7.75%.)

2.25% per pack increase on cigarettes.

Surcharge on personal income tax owed at the following levels:

2% on married couples making \$100,000 to \$250,000

2% on a single person making \$60,000 to \$150,000

3% on married couples making \$250,000 or more

3% on a single person making \$150,000 or more

3% Surcharge on Corporate Income Tax owed

Click thru tax on certain items purchased online

The budget is now on the desk of Governor Perdue and she has earlier indicated that she does intend to sign it into law.

Following the passage of the budget earlier this week, the Senate announced its intention to adjourn session for the year today (Friday). The House intends to complete its work next Monday or Tuesday. As a result, a flurry of activity has been ongoing at the General Assembly this week. I am pleased to report that The Greensboro Partnership's legislative agenda items were well received

Land Development Ordinance

by the General Assembly. Below is a summary of the results:

Joint School of Nanoscience and Nanoengineering

Under the adopted budget, the Joint School of Nanoscience and Nanoengineering is slated to receive an additional \$1 million in new recurring funding bringing the School's total appropriation to \$3.9 million annually. This increased funding will further assist the School in its ongoing establishment and growth.

National Science Foundation/Engineering Research Center

The Engineering Research Center in the College of Engineering at NC A&T State University will receive \$2 million in matching funds on a recurring basis under the adopted budget, which will serve as matching funds for an \$18.5 million grant from the National Science Foundation.

Flight Simulator Tax Exemption SB1057, a bill expanding the sales tax exemption on flight simulators, was also approved by the General Assembly in its final actions of the legislative session. This expanded tax exemption allows the tax-free purchase of flight simulators when purchased for the purpose of training aviation crews for planes weighing less than 12,500 lbs. This exemption will benefit Greensboro and the Piedmont Triad through the expected creation of jobs as our region moves forward in the continued development of an aviation cluster.

Jordan Lake Stormwater Rules

HB239, addressing concerns involving the existing development and wastewater treatment rules promulgated last year by the NC Environmental Management Commission, was passed by the General Assembly and signed into law by Governor Perdue on June 30, 2009. A final issue involving new development requirements within the original Jordan Lake rules was also approved by the General Assembly this week. This change, agreed to by all interested parties, provides the same level of environmental protection to Jordan lake but simply changes the means by which required controls may be implemented.

10th Annual State of Our Community Luncheon

This year's Greensboro Chamber of Commerce Annual State of Our Community Luncheon plans to be different than all those past. Instead of speeches, we decided to shake things up with a panel discussion. We have confirmed Mayor Yvonne Johnson, City of Greensboro; Chairman Skip Alston, Guilford County Board of Commissioners; and Chairman Alan Duncan, Guilford County Board of Education to serve as our panelists. Chuck Burns, Chair of the Greensboro Chamber of Commerce Operating Group, will moderate.
